**Email or Mail Commission Certificate** - Upon commissioning, the Secretary of State will send you your commission certificate, email or mail us this information. We will mail your customized stamp and other supplies within three business days after we receive notification of commission. All NOTARY PUBLIC OF AMERICA stamps and seals come with a Lifetime Guarantee.



# **Consider these Actual Cases:**

• A property owner and a bank sued a Notary. She did nothing wrong, but was deceived by identity thieves. The Notary chose to pay to settle both lawsuits rather than endure prolonged litigation. An Errors & Omissions policy would have protected her.

- A Notary witnessed the signature of a minor on a deed transfer, using a passport as identification. When the parents divorced, the Notary was sued on behalf of the child by her legal guardian.
